Minutes 2015 Annual Meeting of Members

1) Review and approve proposed agenda for Annual Meeting of 2015

A motion was made to approve the proposed agenda for the annual meeting.

2) Approval of the Minutes - Annual Meeting 2014

A motion was made to approve the minutes from Annual Meeting 2014.

3) Report of the Treasurer - Financial Report

Ms. Friberg presented the financials, balance sheet as of Sept 30 2015 and Profit/Loss for Oct 2014 – Sept 2015. The board approved the budget for 2016 at the BoD meeting. There is an increase in income, which is mainly due to the Nor-Am conference. NADIC has maintained a stable income from membership dues compared to last year and it is expected to stay on the same level in FY16. NADIC also has income from the NACC-MA, Innovation Norway, the Ministry of Foreign Affairs and the Ministry of Trade, Industries and Fisheries. The activity level and correspondingly expenses has been higher, but this has also given more income. Mr. Skjelstad notes that NADIC has been generous with the NACC-MA with respect to hours demanded.

A motion was made to approve the financial report.

4) Annual report

Mr. Skjelstad presented the annual report for 2014-2015 activities, stating and describing the highlight of the past year. In connection with AUSA 2015 there was a reception at the ambassador's residence. However, this was not straightforward. NADIC should not take for granted the support we receive from the ambassador, but this reception is a great example of the value NADIC brings its members. The annual reception gives access to very important people, and NADIC should make sure that we get the reception next year. Mr. Gustafson pointed out that the ambassador picked out the VIPs. The support from the ambassador and the embassy is key to get VIP's like Heidi Shu to attend. Mr. Skjelstad argues that as we did not get a lot from the Congressional side, we can start planning the Nor-Am to get Congressmen to attend. Mr. Skjelstad notes that the Nor-Am 2015 conference was a big success and that NADIC should focus on hosting one big event instead of several smaller ones. The Nor-Am conference should continue to be NADIC's big event. The embassy has been

deeply involved, which is an explanation for the great success. Mr. Gustafson notes

that Frank Kendall was supposed to be one of the key speakers on Nor-Am 2015 but

due to last minute changes it didn't work out. This should not happen again as it

creates tension within the Nor-Mod. Mr. Gustafson and Mr. Skjelstad stresses that

we should continue to invite and also do some back channeling to get the high level

speakers. As the Minister of Defense Øystein Bø is invited we should push for Kendall

for Nor-Am 2016.

Mr. Skjelstad mentions the commemoration NADIC hosted of the Norwegian

Liberation Day and that we should make this a tradition. NADIC will continue the

collaboration with FSi as it is a good arena for recruiting new members. Discussion

followed on the annual ComDef conference and Mr. Gustafson stresses that it is

important to have a strong attendance. Mr. Gustafson suggests we build a

relationship with the people behind the ComDef conference and that they might

support NADIC. An update followed on the working dinner with the Conservative

Party. Mr. Svensgård notes that the White Paper is completed and waiting to be

approved. The paper is an update of the current strategy but not with any significant

changes. FSi has been collaborating closely with the Conservative Party in building

the paper. Mr. Skjelstad notes that NADIC will continue to participate in events like

the working dinner. Mr. Skjelstad gave an organizational update. NADIC has

increased its staff and upgraded the general manager position. NADIC will continue

the internship program with American University. NADIC will continue to work

closely with the Norwegian Embassy, the office of the Defense Attaché and the

NACC-MA. Mr. Skjelstad stresses that we should aim to get the Defense Attaché to

attend more events. Discussion followed on the AFA event and that we should push

for the Defense Attaché to attend.

The motion to approve the annual report was carried.

5) Appointments and re-election

Mr. Vidar Skjelstad presented the Board of Directors and suggested a motion to:

6) Points of Discussion

6 a) Message from the President

NADIC is dependent upon providing value for its members. NADIC works to establish a fair playing field in the US market for its members to compete for defense contracts. This is a great task and the process is incremental. It is important to work closely with influential people across the board and Washington, DC. NADIC is moving forward at a slow pace. Mr. Skjelstad makes a comment on agenda point 6b from last year about establishing a Nor-Am treaty. The working group consists of Scott Burk, Torgrim Jørgensen, Arne Skjærpe, Einar Gustafson... but the group has not been very active thus far. Mr. Skjelstad strongly encourages the group to continue this effort. Ms. Friberg is currently in Norway to get her Visa and uses this as an opportunity to conduct research that NADIC can leverage. The value NADIC brings to its members is access to important people. Even the smallest company will get access to people it normally would not. Going through NADIC is easier than going as an individual company.

6 b) Discuss accounts receivables and which actions to take

NADIC will follow a set procedure to handle accounts receivables. After the initial invoice, the member company will receive a phone call from the staff after 60 days. After 90 days the president will issue a formal letter. If the member company has failed to submit payment after 120 days the membership will be terminated.

6 c) Discuss benefits for the respective membership levels

There is and has to be a differentiation between bronze and gold memberships. Thus far, bronze members have received the same treatment as gold members, and there has not been any differentiation. Ms. Friberg notes that the respective membership levels and their benefits are listed on the NADIC brochure and on the web page, however, NADIC has been kind and given bronze members the same treatment. In conclusion, NADIC should be more strict and not give members more than what they pay for. Mr. Sioma notes that the initial rule was to only invite presidents, CEO's and board members to NADIC VIP dinners, but NADIC has moved away from that rule. Mr. Skjelstad suggests NADIC goes back to the initial rule.

6 d) Discussion on whether NADIC should consider attending other shows and exhibitions

There is a general agreement that NADIC should have stronger attendance on Air Force shows, especially if the event takes place in Washington DC or within close proximity. Mr. Sioma points out that the AFA in National Harbor is a good opportunity for companies as it comes in relation to other shows as well. Mr. Jørgensen mentions SOFIC that takes place in Tampa in May and that the event is especially good for small Norwegian companies with niche products. SOFIC focuses on innovation and is an early buyer. Mr. Jørgensen stresses that it is difficult to get a booth, and that generally one needs a 40x40 to secure the booth. He recommends getting a booth immediately. Discussion followed on whether NADIC should become a member of NDIA (the US equivalent to FSi), and if so, NDIA should be able to become a member of NADIC in return. Mr. Burk notes that KPS is attending SOFIC this year and if necessary they can leverage and assist. This is to be followed up with Chloe, Nina and Chantel. Mr. Sioma comments that it could be advantageous to go through the FSi banner to avoid the issue of whether NADIC should allow (NDIA?) becoming a member. Ms. Friberg and Mr. Svensgård will coordinate this effort.

6 e) Input from members

None.

7) Other business

Mr. Cunningham brought up the question whether it is too soon to suggest potential speakers for the Nor-Am spring conference. Mr. Gustafson replies that it is very much appreciated. Mr. Skjelstad notes that NADIC has to decide on a topic for the conference. Mr. Gustafson gave an update on the Nor-Am treaty working group and the progress so far. The working group has not been very active. The group has conducted a working dinner and a gathering at the Norwegian Embassy. He stresses that opinions on whether we should aim for such a treaty is divided within the Norwegian Ministry of Defence, and that this makes it difficult to conclude on recommendations and the way forward. Mr. Gustafson has met with his counterparts at the embassies of UK and Australia to learn more about their treaties with the US, how it works and how they are different from the MoU's and the Declaration of Independence. The topic of a Nor-Am treaty was also carefully worded at the Nor-Am conference 2015. Mr. Gustafson underlines that it is a good idea to extend our networks in the part of the government that would be involved in this question. Mr. Gustafson notes that Puneet Talwar approached NADIC, which shows that NADIC grows stronger. Discussion followed on whether NADIC can become part of NTIP and whether MoU or a treaty would give the same treatment as NTIP. Mr. Gustafson notes that the industry should speak with a strong voice if there is a wish to obtain a treaty, and in addition we should push to have the MoU revised as it is not updated and does not reflect the current situation and needs. Mr. Gustafson stresses that we need to build awareness within the Ministry of Foreign Affairs to get their support


WORKING DINNER WITH THE CONSERVATIVE PARTY


NADIC'S 4TH ANNUAL NORWEGIAN-AMERICAN DEFENSE CONFERENCE

Speakers included Deputy Secretary of Defense Robert Work, Deputy Defense Minister Øystein Bø, Congressman Rick Larsen (D-WA), Lt Gen Arnold Bunch, Military Deputy, Office of the Assistant Secretary of the AF for Acquisition, Dr. John Hamre from CSIS and many more. During the luncheon, DEFSEC Work and Bø held a press conference where DEFSEC Work stressed that the U.S. will look towards more industrial cooperation with Norwegian defense firms in the future. The Annual Norwegian-American Defense Conference was a great success, and will continue to be NADIC's signature event.
